#### On The Air

When you pitch in to help any club, you are helping Amateur Radio. When you help Amateur Radio, you help *every* club. Attaining that tricky balance of Independence and Unity is almost automatic when you approach it this way.

There is a further parallel to the United States. Every club is and ought to be a free and independent organization. But all clubs share many common purposes, and many thriving clubs choose to band together at the national level by affiliating with The American Radio Relay League.

Becoming a League Affiliate helps your local club in some very real ways. The League can direct potential members your way, and provide your club with help in carrying out your activities. Your affiliation and your members' League memberships help support the League's missions that protect our hobby from those who want our frequencies, generate destructive QRM or want to take away our antennas.

It's a fact there wouldn't be Amateur Radio at all if not for the efforts of the ARRL. We owe them our support—both moral and financial.

Have a safe and happy Independence Day. Take time to remember all those who paid the ultimate price for our freedoms, and resolve to do your part to carry on their work.

#### PARA Special Event Station By John Szwarc N3SPW

**EMBERS OF THE** Philipsburg Amateur Radio Association (PARA) are busy preparing for the set-up and operation of Special Event Station W3P July 12 through 16, 2011. This year will mark the third year that PARA has operated the special event station and is the club's biggest event of the year. The special event station is operated entirely from a street fair setting at the Philipsburg Heritage Days celebration and is housed in a vendor style tent. For 2011 three operating positions are planned. There will be two HF stations, one a dedicated CW station and the other running SSB. The third operating position will be a 2-meter station which typically monitors "The Big .43 Repeater" (146.430 MHz, +1 MHz offset, PL 173.8 Hz). Antennas for the special event station are all homebrew creations of PARA's "Antenna Man" Lou WB3AAI. The 2-meter band antenna is a homebrew Slim Jim design

housed in a length of PVC plumbing pipe and supported on a 40 foot portable mast system. The HF antennas are wire dipole antennas and supported with telephone poles or any other convenient support structure.

All stations confirming a 2-way QSO with the special event station will receive a commemorative QSL card. While the design for the 2011 QSL card has not yet been finalized, the 2010 card featured images of the Philipsburg Boro Hall and one of the the Civil War era cannons which is located in the park adjacent to the boro building. It takes a large number of dedicated club members to staff and operate the special event station each year. The effort is spearheaded by PARA President Dave Runk AA3EJ and Lou Trubiani WB3AAI. They depend on the assistance of many helping hands to make it all work. It really is a group effort with most PARA members contributing their time, equipment or resources in some fashion. If you would like to try your hand at operating a special event station there is always room for a new operator. Just stop by the booth and let whoever is on duty know what you would like to do.

Special event station W3P is PARA's most visible outreach to the community. This is our chance to demonstrate to the public what amateur radio is and can do. Occasionally members of the public are interested enough to take a seat at an operating position and try their hand at a contact or two. Several people have become licensed as a result of the Heritage Days booth. It's a great way to grow new hams and grow our club. HE BAKER TRAIL is a 132mile hiking and backpacking trail, following forest paths, old jeep trails and dirt roads through woods, farmlands, along rivers and creeks. The Baker Trail is one of the 18 state-designated hiking trails and is included on the trails map of Pennsylvania.

The trail begins in the Cook Forest Area, and terminates in the Freeport area.

The Rachel Carson Trails Conservancy took over maintenance of the trail after the prior organization, American Youth Hostels-Pittsburgh, became defunct. As a way of promoting the trail, RCTC started a 50 mile footrace, known as the Baker Trail Ultra Challenge. The race is an Ultra-marathon, is held annually, and is run on a different segment of the trail each year. This year is the seventh running, and will be on the northern segment, from Cook Forest, to Brookville.

The race will begin at 0630 hours on Saturday August 27, 2011 The start line is on Muzette Road in Clarion County, and works its way via roads & trails along the Clarion-Jefferson County line through Corsica to Summerville, and new this year will follow the old Conrail low grade to Brookville, terminating at the Brookville YMCA on Main St.

KA3YCB & KB3FPN, along with a couple others have assisted with this as an ARES function for four of the last six years, foregoing the southern legs. We utilize the 147.105 repeater. We usually run mobile, but if you can hit the 105 repeater with a HT, that would work. I would like to see some more participation from area hams. The website says the race is from 0630-2030 hrs, but

most days we have been released in the early for some reason, but everyone remembers afternoon.

Several of the Rachel Carson members have been impressed enough to take training and become hams themselves. The race director. manager, and logistics persons (at least) are licensed.

There are the start & finish lines, and 11 aid stations/checkpoints in between. Not all are manned at all times.

If you are pressed for time, you can perhaps cover one aid station for the duration of its existence for 3-4 hours, or usually until all runners have passed which usually is sooner than that. If you have more time, you can leap-frog to another station. Even if you can put in a few hours, it would help. It would be great if we could get 6-8 hams. It isn't complicated work; we have a very loose net structure, (at least in the past) and basically relay needed information. They have water & snacks at each point, and you get a T-shirt for your effort.
